Generally, for filers of 2023 paper IRS Income Tax Returns, the 2023 IRS Income Tax Return information is available for the IRS Data Retrieval Tool or the IRS Tax Return Transcript within 6–8 weeks after the 2023 paper IRS Income Tax Return has been received by the IRS.
