Manatee Technical College (MTC) offers a money-back guarantee for students who are unable to find employment in their field of study within six months of completion in the following programs:

- **Master Automotive Service Technology** - CIP #0647060405
- **Automotive Collision Technology Technician** – CIP #0647060306
- **Heating, Ventilation, Air-Conditioning/Refrigeration (HVAC/R)** – 0615050110
- **Firefighter/ Emergency Medical Technician - Combined** - 0743020313

**Students are only eligible for a refund for out-of-pocket expenses.** Students must meet **ALL** of the requirements listed below to be eligible for a refund:

- **Student must be a graduate** – Students must meet all requirements of the program and be a program graduate after June 27, 2024.
- **Student must hold the appropriate and required industry certification for the employment area.**
- **Student attendance** - Student must have attended 90 percent or more of the scheduled hours for the entirety of the program.
- **Student program performance** - Student must have earned a B+ (87-89) or higher average in the program.
- **Job search documentation** - Student must show documentation that they have applied for a minimum of five jobs, completed the interviews, without an offer of employment.
- **Development of a student career plan with the institution's career services department. Student must have done all the following and provide the documentation.**
  - Met with MTC Career Counselor at least once during enrollment.
  - Earned a Ready to Work Credential (Level 4 or better).
  - Provide an error free updated resume.
  - Completed the MTC program exit survey.
  - Kept the instructor informed throughout the process of securing employment.
- **Attendance at outside class learning opportunities** - Students must have attended at least 80 percent of outside of school approved learning opportunities provided in their program.
